#### 1. Data Controller

#### 2. Data Collection and Use

We collect and process personal data necessary to provide our services. This includes:

- **Payment Information**: Processed securely via **Stripe** (we do not store payment details directly).

We collect this data to:

### 3. Data Storage

We use trusted third-party platforms to store and process your data:

- **Zenfit**: For secure storage of client information, including intake forms and progress tracking.
- Stripe: For secure payment processing.

Both platforms comply with GDPR and have their own privacy policies governing how they process data.

### 4. Legal Basis for Processing

We process your data based on:

- Consent: You provide explicit consent when you sign up for our services.
- Contractual Obligation: To deliver the agreed-upon services.
- Legitimate Interests: To improve our services and respond to inquiries.

### 5. Data Retention

We retain your personal data only as long as necessary to fulfill the purposes for which it was collected:

- Client data: Retained for the duration of your subscription and up to 6 months afterward for administrative purposes.
- Payment data: Retained in accordance with legal and tax obligations.

### 6. Data Sharing

We do not sell or share your data with third parties except for:

- Stripe and Zenfit, as necessary for payment processing and service delivery.
- Legal authorities, if required by law.

### 7. Your Rights

Under the GDPR, you have the following rights regarding your personal data:

- Correction: Correct inaccuracies in your data.
- **Erasure**: Request deletion of your data (subject to legal and contractual obligations).
- Restriction: Limit how your data is processed.
